# West Sacramento Deputy Fire Chief hopes to inspire more diverse fire crews as she takes over as Fire Chief in Woodland

**By Daniel Wilson** 

Early in her career, West Sacramento Deputy Fire Chief Rebecca Ramirez, who will take over as the first female fire chief for the Woodland Fire Department on Feb. 27, said she received a compliment that embodied what she and most women desire in their careers. It came in the form of overhearing an "old timer" on the phone telling someone that she was a woman but that he just

"That, to me, had always stood out as all I ever wanted," Ramirez said. "Don't look at me for my gender or the color of my skin or the way I speak; Look at me as what I can contribute to the organization."

considered her a part of the

crew.

Ramirez said she has never felt discriminated against as a woman in firefighting. By working as hard as possible and being as selfless and respectable as possible, she feels she's been able to overcome any barriers she has faced.

"I am glad to be represent-

ing women in leadership roles, particularly in roles that are not so typical, [like] the fire service," said Ramirez, who started her tenure with the West Sacramento Fire Department in 1993. "I think we have struggled in getting women into the fire service as a whole and we need to work on that a little bit. Maybe for people seeing me in that role, some young girls...will realize that fire service is a true opportunity for them."

Battalion Chief Steve Binns, who's worked for the West Sacramento Fire Department since 1990, will be replacing Ramirez as deputy fire chief.

As battalion chief, Binns is responsible for working handson with the fire crew and running day-to-day operations for the department. In his new role, he'll work closely with the fire chief to balance budgets, implement new programs and processes and run current programs like consortium training sessions, where all of the county's fire departments learn to cooperate in preparation for



large-scale emergencies.

"It's just more broad-based, more higher-level looking at things," Binns said. "I've always kind of operated on today and at this [new] level, [I'll] need to operate more about tomorrow."

Ramirez said the fire department works diligently to help prepare its staff for the job above them in the case of promotion, so Binns already has some experience with some of the duties of his new role.

"We're going to definitely miss her," Binns said. "We're on a steep learning curve over the next two or three weeks, [but] she's still going to be in the county, so we're going to talk often, I'm sure."

Some of Ramirez's contributions to the West Sacramento Fire Department will have a long-lasting impact on the city. In recent years, she was directly involved with improving the city's Insurances Services Office rating, which ranks the department on its abilities to provide fire protection services and sets insurance rates for city residents and businesses based on the ranking.

She also worked to secure a \$1.2 million grant in May to purchase Self-Contained Breathing Apparatuses, which are worn on the backs of firefighters and provide them with breathable air while inside a burning building, for the department's firetrucks.

"She has been an amazing person to work with," said West Sacramento Fire Chief John

Heilmann. "I think I've learned more from her than she's probably learned from me."

Ramirez's new role is part of a restructuring of Woodland's fire and police departments, which are both currently led by Public Safety Chief Dan Belli-

With the announcement of his retirement, the city decided Bellini's position should be eliminated in favor of a more traditional set up, according to a Feb. 2 press release from the city of Woodland. The fire and police chief positions were previously combined following cutbacks as a result of the 2008 economic downturn.

"I think it's good for the county and good for the fire department," Heilmann said. "I think everyone will benefit in the end."

Ramirez found out about her new position in early February. "It was very exciting to find out about it and I was a little overwhelmed by it," Ramirez said. "The support and the en-

# **Medical and Commercial Marijuana Outdoor Cultivation Now Allowed in Yolo County**

The outdoor cultivation of medical marijuana is permitted in Yolo County. But, there are conditions in place that will address neighbor complaints, limit harmful environmental impacts and protect the patient's access to medical marijuana. Only qualified patients can cultivate medical marijuana, and it must be for personal use only. Up to six non-medical marijuana plants may be grown by adults (ages 21 and older) in their own residence, subject to all applicable restrictions contained in Proposition 64.

Regardless of the number of qualified patients that reside on the property, who participate either directly, or indirectly in or benefit from the cultivation, the 100 square feet limitation is imposed. This area, per legal parcel, cannot not exceed the 100 feet limit whether or not the

rity. Cultivation can be for personal medical use only. It cannot be sold, distributed, donated or provisioned to any other person or entity.

Commercial cultivation is allowed by permit and requirements and restrictions apply. Non-medical marijuana commercial activities are illegal until the State begins issuing licenses to operators in 2018. Currently, the Central Valley Regional Water Quality Control Board (CVRWQCB) issues a permit. Any garden canopy must be between 1,000 and 43,560 square feet. Cultivation by permit of less than 1,000 square is prohibited. Cultivators must be a lessee of the property, or the record owner.

There is a provision of written consent to reasonable on-site compliance inspections. The grower must agree to indemnify and hold harmless the Yolo County. Those owning, leas-

ing, occupying of having charge of the property who have been convicted of certain felonies in any jurisdiction are prohibited from cultivating medical marijuana in Yolo County.

Participation in a local track and trace program in required by Yolo County. This program is designed to track the movement of medical cannabis through each step of the supply chain, as well as trace the product back to its origin. This is a technology that is known as "track and trace". By doing this the county can be assured that the medical cannabis grown in the county complies with local and state laws.

This program is critical to demonstrate that the county's medical cannabis regulatory program incorporates principles that are important to local and federal law enforcement laws. These include the distribution of cannabis to minors, preventing the

sion of cannabis to other states, preventing cannabis from supporting criminal enterprises and preventing the growing on cannabis on public lands.

The track and trace solution uses secure stamps combined with software and information-based security. The secure stamps are a proven method of providing track and trace functionality, fighting counterfeiting, and allowing for data collection and business intelligence. After a cultivator harvests and packages their crop, they apply a traceable, counterfeit-resistant stamp to the packaging.

The stamp includes a QR code and unique stamp number that is coded with information about the product. This includes size, strain, grower and more. As the package passes through the supply chain-from cultivator to manufacturer to distributor to

The City of West Sacramento is asking for the public's help in keeping vehicles off levees surrounding the City.

There have been several incidents of trucks, cars and motorcycles driving up and down the sides of levees causing deep ruts which can lead to severe erosion during periods of heavy rain. In addition to potentially compromising the integrity of these levees, it increases the cost of maintenance. Reclamation District 900 crews have been inspecting West Sacramento levees 24/7 and report no issues, aside from this vandalism.

Please be vigilant. If you see any suspicious activity on or around our levees, call the West Sacramento Police Department at 372-3375.

Other than on city roadways, vehicular traffic on top of or along the sides of levees is illegal, dangerous and should be reported immediately. Violators face prosecution for driving an unauthorized motor vehicle on a levee.

Lorn W. Fredericksen August 5, 1934 - February 14, 2017



# **Tuleyome Provides Events and** Volunteer Opportunities for the Public

Tuleyome is a Woodlandbased nonprofit conservation organization. They have partnered with the University of California's extension program to teach members of the public how to become "Certified California Naturalists". Their goal is to inspire members of the public to protect, restore, and enjoy landscape in the Northern Inner Coast Range region.

No advanced degrees or previous naturalist experience is required. The program will launch in 2018 at the Woodland Public Library. If you are interested you can sign up for their mailing list at www.tuleyome.org.

Tuleyome was founded in 2002 as a volunteer advocacy-oriented nonprofit conservation organization. The organization serves communities mainly throughout Yolo, Lake, Napa, Mendocino, Solano, Glenn, and Colusa counties. They also do outreach in Sacramento County.

Tuleyome spearhead-

ed the formal California State Wild and Scenic River designation for upper Cache Creek. They worked with Senator Barbara Boxer to designate Cedar Roughs and Cache Creek Wilderness Areas and additions to the Snow Mountain Wilderness.

In 2015, they were successful in permanently protecting the Berryessa Snow Mountain region as a National Monument. This was considered to be one of Tuleyome's most significant accomplish-The National ments. Monument encompasses over 330,000 acres of federal public lands which include the core areas of the Cedar Roughs, Cache Creek, and Snow Mountain Wilderness.

This area includes over 65,000 acres of road-less area, and the critically important connecting migratory corridors that link them together. The region will become an important ecological addition to the National Conservation Lands.

At Tuleyome, they believe that everyone deserves access to the outdoors, and their nationally award winning program "Home Place Adventures" encourages people of all ages to become more connected to and involved with the natural world that surrounds all of us. In 2012, the HPA Program was nationally recognized. It won the National "Kids and Trails Award".

In 2014 they launched the "Nature and You" lecture series in partnership

with Yolo County Library. This partnership helps to educate the public about the local natural environment and introduces them to the scientists and businesses who work directly in this field.

With their community partners they continue to expand the program with the publication of educational books for adults and children that are based on their popular "Tuleyome Tales" newspaper feature articles and

**ORDINANCE 17-1** 

10.04.060(A) SECTION PARKING, AND ADDING CHAPTER 10.26 CONCERNING PARKING METERS

Sacramento does ordain as follows: Section 1. Purpose and Authority.

Chapter 10.24, and to add Chapter 10.26 of the Municipal Code. The City Council enacts this ordinance in accordance with the authority granted to cities by state law.

Section 2. Amendment of Section 10.04060(A) Section 10.04.060(A) of the West Sacramento Municipal Code is hereby amended to include the following additional definitions, to be inserted in alphabetical order:

'Parking meter' means any mechanical device or meter not inconsistent with this title placed or erected for the control or regulation of parking by the authority of this title.

"Parking meter space" means any space within a parking meter zone, adacent to a parking meter or controlled by a pay-by-space or pay-and-display machine, which is duly designated for the parking of a single vehicle by lines painted or otherwise durably marked on the curb or on the surface of the street.

"Pay-by-space/pay-and-display machine" means any mechanical/ means any mechanical/ electronic device or mechanism not inconsistent with this title placed or erected for the control or regulation of multiple parking meter spaces by the authority of this title.

Section 3. Amendment of Chapter 10.24. Sections 10.24.020, 10.24.120, and 10.24.270 of the West Sacramento Municipal Code are hereby amended as follows:

Where prohibited.

No person shall stop, park or leave standing any vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or to comply with the direction of a peace officer or official traffic-control device, in any of the following places: A.In any area established as a no-parking area when such place is indicated by appropriate signs or marking, except that a bus may stop at a designated bus stop;

**B.**On any street or highway where the use of such street or highway or a portion thereof is necessary for the cleaning, repair or construction of the street or highway or the installation of underground utilities, or where the use of the street or highway or any portion thereof is authorized for a purpose other than the normal flow of traffic, or where the use of the street or highway or any portion thereof is necessary for the movement of equipment, articles or structures of unusual size, and the parking of such vehicle would prohibit or interfere with such use or movement, provided that signs giving notice of such parking restrictions are erected or placed at least twenty-four hours prior to the effective time of such restriction:

# West Sac PD Offers a Safe and Secure Exchange Location

Break ups and divorces are always emotional, but when there are children involved it often elevates those emotions ten fold. Even when custody orders are in place it's not always as simple as just handing off the kids. Emotions flare, challenges arise, and all too often what should be a simple and civil handoff of the children, ends up volatile and hostile. This sometimes ends with two parents fighting in front of the children. In Yolo County, if the terms of a custody agreement are not being followed, the Child Abduction Unit, in Woodland, are the ones who enforce those terms. However, the city police frequently get dispatched to civil stand-by calls, because one or more people are in fear of just such a situation. Though the Police are in fact here to protect and serve, and they do their best to do that, many times they must prioritize their time.

ally fall low on the priority list. This is in not to say that they think your children are low priority! They simply often have other situations occurring that must be attended to first. For this reason, the response time for a civil stand-by call is completely unpredictable.

West Sac PD does in fact care about the citizens of our town, and to help with this situation they have created a "Safe and Secure" exchange site. As of February 14th, they Civil Stand-by calls usu- have designated two specific parking spots in front of the Police Departments that are under 24 hours video surveillance. These spots are clearly marked with reflective signs that indicate their use. Though the entire parking lot of West Sac PD is under video surveillance, these two spots are best covered. with the best view. In addition to hoping that this exchange spot will reduce crime in an exchange scenario, they are also hopeful it will minimize disputes during child custody exchanges.

This area is not strictly for custody exchanges. Many people engage in private sales of items over the internet. There is always a risk involved when engaging in this situation. According to the National Crime Prevention Council California is first in the country in reports of cyber and Internet connected crimes. Though the responsibility falls on the individuals to protect themselves and their families through safe online practices, the West Sac PD is encouraging you to

complete the transfer of items that are not being sent through the mail, at the safe and secure exchange location. The Internet Crime Complaint Center (ic3), a group that is partnered with the FBI, Department of Justice and the White Collar Crime Center suggests when you are conducting business online, be wary of PO Box numbers. Request a street address if dealing with a business, and when dealing with an individu-



al always get a name and phone number. They also suggest that before you meet with anyone, google their name and phone number. Make sure that they are legit, and that the number is valid. If it is not, it might be safer to go elsewhere. However, if all checks out, meeting at a safe and secure exchange site could detour any bad intentions.

Though the safe and secure site is not fool proof,

the police feel that this may offer a little more security in a potentially dangerous situation. Please be aware that there is not someone monitoring that surveillance 24/7, and that the videos are only kept for 30 days! So if you find yourself in a bad situation do not hesitate to call 911, OR you can run into the lobby of the police department and pick up the red phone. The red phone connects you directly to dispatch. West Sac Police Sergeant

Roger Kinney stated "If for some reason the person that you are dealing with refuses to meet at a safe and secure location site, always be sure that you meet in a very public place where there are a lot of people... preferably somewhere that has video surveillance, such as Raleys. If you don't know if there is video surveillance, ask... or pick somewhere else. Just make sure that there are a lot of people around."

urban uses has resulted in the loss of as much as 95% of historical habitat for the giant garter snake. Cryptic and notoriously wary, this species is among the most difficult of California's garter snakes to study, vet ecological information on which to base management and regulatory decisions is urgently needed to guide decision-making. This presentation will provide notes on the habits and ecology of giant garter snakes, discuss the role of land use and water management on their current distribution, and provide insights regarding the steps needed to maintain the species into the future. Attendees will also be provided with a discussion of steps the citizen scientist can take to assist with the recovery of this highly charismatic animal. Eric Hansen is a herpetologist living in Sacramento. Raised and inspired by his herpetologist father, Eric has a lifetime of experience with the giant garter snake. He has worked as an independent consultant and researcher since 1998. Eric specializes in threatened and endangered reptiles and amphibians of the Central Valley. With primary interests centering on conservation ecology, his collaborative projects have covered a range of interests, including population genetics, contaminants and toxicology, demography, and spatial ecology. Flyway Nights is a monthly speaker series highlighting environmental issues, natural history of Northern California wildlife, and current research topics in conservation.
